

**SUMMARY ANNUAL REPORT**  
**FOR I.A.T.S.E. LOCAL 504 HEALTH AND WELFARE TRUST FUND**

This is a summary of the annual report of the I.A.T.S.E. Local 504 Health and Welfare Trust Fund, E.I.N. 95-6100367, Plan No. 501, for the year ended June 30, 2019. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has contracts with Kaiser Permanente, Health Net, Delta Dental Plan of California and The Union Labor Life Insurance Co. to provide certain medical, dental, life insurance and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ended June 30, 2019 was \$1,158,327.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$1,299,422 as of June 30, 2019, compared to \$1,261,485 as of July 1, 2018. During the plan year, the plan experienced an increase in its net assets of \$37,937. During the plan year, the plan had total income of \$1,512,330 including employer contributions of \$1,452,201, participant contributions of \$3,948 and gains from investments of \$56,181.

Plan expenses were \$1,474,393. These expenses included \$1,356,490 in benefits paid to or for participants and beneficiaries and \$117,903 in other expenses.

1. An independent auditors' report;
2. financial information and information on payments to service providers;
3. assets held for investment;
4. transactions in excess of 5% of the plan assets; and
5. insurance information.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (1200 Wilshire Boulevard, Los Angeles, CA 90017) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
